The big picture: the corporate mission of Bruckner University

The library's part (1): implementing Phaidra

The library's part (2): promoting Phaidra

„Im Sommer 2019 ging das digitale Repotitorium PHAIDRA online. Ende 2019 waren ca. 200 Dokumente abgelegt. Schwerpunkt sind die Hochschulschriften (BA, MA) der Universität, Filme der Künstlerin Editta Braun, Veröffentlichungen aus der Forschungs- und Lehrtätigkeit der Universität und Dokumente aus der Bibliotheksgeschichte. Weitere inhaltliche Projekte sind in Arbeit.“

“In the summer of 2019, the digital repository PHAIDRA went online. By the end of 2019, approximately 200 documents were stored. The main focus is on the University's theses (BA, MA), videos by the artist Editta Braun, publications resulting from the university's research and teaching activities as well as objects documenting the history of the library. Several projects to add further content are in progress.”

Phaidra - das digitale Repositorium

In unserem Repotorium **Phaidra** werden die digitalen Ergebnisse der wissenschaftlichen und künstlerisch-wissenschaftlichen Forschung an der Bruckneruniversität veröffentlicht. Seit Anfang 2019 werden Bachelor- und Masterarbeiten unserer Studierenden hochgeladen. Zusätzlich bietet **Phaidra** einen wachsenden Bestand an wissenschaftlichen Ergebnissen der Lehrenden, Lehrmaterial, Digitalisaten der Bibliothek sowie Audio-/Videomitschnitten von Darbietungen an der Bruckneruniversität.

Ist der Zugriff auf ein Objekt auf Universitätsangehörige beschränkt, ist eine Anmeldung mit dem Bruckneronline-Konto notwendig. Durch Klicken auf den grauen Login-Button in der Menüleiste können sich Studierende und Mitarbeiter*innen der ABPU anmelden.

Phaidra dient der dauerhaften Sicherung von digitalen Beständen an der Anton Bruckner Privatuniversität. Basierend auf dem von der Universität Wien entwickelten gleichnamigen "Digital Asset Management System" (Software: Fedora Commons) ermöglicht **Phaidra** die digitale Speicherung, Verwaltung und Langzeitarchivierung von Medienobjekten, insbesondere von Grafik-, Text-, Video- und Audiodateien aus Forschung, Lehre und Administration.

Phaidra - the digital repository

In our repository, **Phaidra**, the digital results of scholarly and artistic-academic research at the Bruckner University are published. Since the beginning of 2019, our students' bachelor's and master's theses have been uploaded. In addition, Phaidra offers a growing stock of research from the teachers, teaching material, digitised material from the library, as well as audio/video recordings of performances at the Bruckner University.

If access to an object is restricted to university members, registration with a Bruckneronline account is required. ABPU students and staff can register by clicking on the grey login button in the menu.

Phaidra is used for the permanent backup of digital holdings at the ABPU. Based on the "Digital Asset Management System" of the same name (software: Fedora Commons) developed by the University of Vienna, Phaidra enables the digital storage, administration and long-term archiving of media objects, in particular graphics, text, video, and audio files from research, teaching, and administration.



Presented in the first chapter is a brief biography of Beethoven, the history of his Sonata Op. 106, a brief definition of the term "Hammerklavier" as an instrument and an overview of the type of pianos Beethoven used to play. The second chapter provides a detailed musical analysis of the piece and examines the challenges that a performer/interpreter faces when studying the work without the original manuscript. This third chapter outlines the conclusions drawn from this study.
